Partial reopening of schools - reg.

Madam/Sir,

As per the new guidelines issued by the MHA the students of classes 9 to 12 can now visit their school to solve their subject related queries with the written consent of their parents'. The vidyalayas may therefore arrange special classes to address the queries of the students in accordance with the latest SOP issued by MoHFW.

Stated below are a few suggestions that may be followed by the vidyalayas.

- 1. Online classes will continue as per schedule.
- 2. Students willing to attend vidyalaya for clarification of doubts in various subjects may be identified by the class and subject teachers.
- 3. Group of 10-15 students with common areas of doubt to be formed.
- 4. The Principal along with teachers may prepare a schedule such that doubts of students in 3-4 subjects are resolved on the day students attend vidyalaya, without disturbing the online teaching schedule.
- 5. A written communication /consent letter to be taken from the parent regarding their willingness to send their ward to the vidyalaya.
- 6. The Vidyalaya must arrange for a virtual PTM to brief the parents of the students attending Vidyalaya about
  - a) Safety norms followed by the school.
  - b) Details of the time table/ Schedule (dates and timings of the classes, etc.)
  - c) Arrangement for transportation for their ward.
- 7. The concerned subject teacher must try to solve the queries of the students during class and provide them all the supplementary material required.
- 8. All government guidelines such as thermal screening, social distancing, wearing of safety gears, sanitization of classrooms and corridors, hand washing and respiratory etiquettes etc to be implemented by the school.
- 9. Monitoring the status of teachers and other staff using Arogya Setu App to be done every day. 50% of the staff to be called as per MHA orders.
- 10. Other instructions as deemed relevant may be issued by the Regional Offices in accordance with the guidelines issued by State/District Authorities.

Vidyalayas in containment zone shall remain closed. Teachers and students residing in containment zones will not attend the vidyalaya. They will however attend their regular classes through online mode.
